Guidelines for Preparation of PhD Synopsis

The sequence in which the synopsis material should be arranged and bound as follows:

1. Title page (A Sample sheet is enclosed: Annexure I)

Title should be as short as possible and accurate.

2. Table of contents

The contents shall enlist the headings of the section and sub-section using decimal notation, as in the text, with corresponding page number against them, flushed to the right.

3. List of Figures

The list of figures along with their numbers and corresponding page numbers against them shall follow the Table of Contents.

4. List of Tables

The list of Table titles along with their numbers and corresponding page numbers against them shall follow the Table of Contents.

5. Introduction

State brief background and introduce the subject in few pages; it should not be directly lifted from the original source. Make your arguments and adopt an analytical introduction to place the problem under investigation in a perspective.

6. Literature review

About 3 to 5 pages or as may be suitable; it is a survey of literature

I. National status

II. International status

on the chosen topic. (Consult the literature articles, books, reports, cases, monographs, data bases, etc.).

7. Objective of your work

To the point, the developments in the area, to emphasize the current status and importance of the research problem identified.

8. Methodology or your work plan

Write your methodology or work plan to accomplish your proposed work.

9. Conclusion including the scope and limitations of your study

A brief report of the work (Highlight major Conclusions / Limitations).

10. References

Candidates shall follow the following style of citation and style of listing consistently throughout (Candidates are suggested to refer most recent bibliography, however, if citations are older than 10 years, then these should be related to fundamental findings in respective field of study and all these must have been referred in the text of the synopsis).

Guidelines for writing Ph.D. synopsis

Following are the tentative guideline on how to write the Ph.D. synopsis by the prospective research scholars as per the need and requirements of their subject and topic.

Preliminary Section-

I Cover page

The cover page will comprise the title of the study and the scholar's name (*Annexure I*).

II Table of contents

Will comprise of enumerations of the tables given in the synopsis section wise.

III Table of figures

Will comprise of enumerations of the figures, graphs, and tables given in the synopsis section wise.

Main Body -

Chapter 1 Introduction

Develop brief writing about your study and its variables explaining the need and importance of the study covering the following points.

- Rationale/ Conceptual Framework/ Brief background of the problem.
- *Need and Significance of the study-* Mention how your study is important to be conducted. What will be the significance and implications of your study on the local level and global level?
- *Statement of the problem-* State the problem to be undertaken in the statement form.
- *Operational definition of the terms* Explain the different terms/variables used as terms in the problem/title in the study.
- *Research questions (If)* write research questions if available on the basis of which the scholar is proposing the research.
- *Objectives of the study-* Enumerate categorically the measurable objectives preferably not more than five of the research to be undertaken.
- *Hypothesis of the study* Construct hypotheses in accordance with the objectives prepared.
- *Limitations of the study-* Clearly mention the limitations of the study. The various generalizations will be done over the different stakeholders.

Chapter 2 Review of related literature

- National Reviews
- International reviews
- *Analysis of the review-* a small summary of the reviews done by the scholar for a proposed topic to ascertain the research gaps and the reasons to take up the study.

Chapter 3 Methodology

- *Type of the research* Write the type of research that you will be using to conduct the study. Mention the reasons to choose this particular type of research method.
- *Population-* Mention the population of the study. Its nature and composition.
- *Sample and Sampling technique* Explain the sample, its size, and its selection using the appropriate sampling technique.
- *Tools used* Mention if there are any standard tools that the scholar will be using or if there will be some tools that the scholar will be preparing.
- *Statistics* enumerate the tentative statistics to be used for the analysis of the data.

Data Collection- Brief description of the tentative data collection procedures/measure may be mentioned in the synopsis.

Discussions- Proposed discussions and interpretations that will come up after the completion of the study may be mentioned by the scholar to support the worth and novelty of the study.

Tentative chapterization in the thesis

The scholars have to tentatively enlist the tentative chapterization of the study.

Bibliography

Write bibliography in APA 6 Style.
