

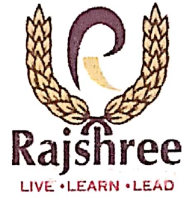

## MEMORANDUM OF UNDERSTANDING (MoU)

Between

Mahatma Jyotiba Phule Rohilkhand University (MJPRU), Bareilly UP India

and

Rajshree Hospital NH-24, Near Toll Plaza Rampur Road, Bareilly

This Memorandum of Understanding is entered into effect on January 04, 2022 by M.J.P Rohilkhand University, Bareilly having its registered office at Pilibhit Bypass Road, Bareilly UP which is represented by Registrar Dr. Rajeev Kumar and Rajshree Hospital having its registered office at NH-24, Near Toll Plaza Rampur Road, Bareilly UP which is represented by its Registrar Shri Dushyant Maheshwari to provide medical treatment/ facilities to the Employees, Staff Members and Students of MJPRU, Bareilly.

Party One: MJPRU, Bareilly is a State University of U.P recognized by UGC and engaged in education and interested to avail medical treatment facility for its Faculty, Staff members and their Families and Students.

Party Two: Rajshree Hospital, a unit of Rajshree Medical Research Institute, Bareilly is a 690 bedded super multi specialty, trust managed hospital providing medical facilities in all the fields and specialties.

This MOU witnesses and it is agreed by and between the parties as follows:

Party One (MJPRU) agrees to provide to Party Two the necessary space in its campus for OPD and for other required furniture, infrastructure, etc.

Party Two will provide Healthcare related services to Party One in the space provided by them. In emergency, the patient should be treated as per the Rajshree Hospital norms.

Party Two will ensure that medical treatment/facility with all due care and accepted standards is extended to the Party One and will provide the following medical services:

- Qualified Doctors for One/Two OPD's preferably Junior Resident/ General Physician/Gynecologist/ Dentist/ Ophthalmologist/ ENT on rotation basis.
- Technicians and Paramedical Staff.
- Ambulance Service, as per requirement
- Sample Collection Facility
- Maintenance of 06 Beds with oxygen support.
- Service will be provided to UPHC during office timing, except emergency.

Party Two will charge OPD Fee: Rs. 5/ for in campus Patient and Rs. 10/ for out campus Patient.

Party Two will not provide cashless facility for Medicine, Ultrasound, CT scan, M.R.I., medical tests, etc.

It is agreed that no employee-employer relationship shall exist between the parties and that the Party Two provide services as an independent contractor for all intents and purposes. The purpose of University Primary Health Centre, MJPRU is to provide basic clinical medical facilities and health care only.

Party One will not interfere in the treatment and medical care provided to its beneficiaries.

Party Two will not be in any way held responsible for the outcome of treatment or quality of care provided by them.

MOU can be terminated by either party by giving one month's prior notice.

Any disputes, claims arising out of this agreement are subject to arbitration and subject to the jurisdiction of Bareilly District Court only.

Any clauses in the MOU can be affected as an addendum, after the written approval from both the parties.

This MOU shall come into force with effect from 04<sup>th</sup> January of 2022 and will remain in force until terminated by either party by giving written notice to this effect.
