

ACADEMIC AND RESEARCH COLLABORATION

CHAUDHARY CHARAN SINGH UNIVERSITY, MEERUT (UP), INDIA

and

MAHATMA ĮVOTIBA PHULE ROHILKHAND UNIVERSITY, BAREILLY, INDIA



This Memorandum of Understanding (MOU) is executed between the following parties:

MAHATMA JYOTIBA PHULE ROHILKHAND UNIVERSITY - A State University established by Government of Uttar Pradesh, situated at Bareilly, UP, India.

The VICE CHANCELLOR, Mahatma Jyotiba Phule Rohilkhand University, Bareilly is duly authorised to enter into and sign the MOU on behalf of Mahatma Jyotiba Phule Rohilkhand University, Bareilly (hereinafter called as 'MJPRU').

CHAUDHARY CHARAN SINGH UNIVERSITY (formerly, Meerut University) - A State University funded by Government of Uttar Pradesh, situated at Meerut, UP, India.

The Vice-Chancellor", Chaudhary Charan Singh University, Meerut is the authorised signatory of this MOU on behalf of Chaudhary Charan Singh University, Meerut (hereinafter called as 'CCSU').

Background of the institutions

Mahatma Jyotiba Phule Rohilkhand University offers Postgraduate and Doctoral research programs in multiple disciplines leading to Masters and PhD degrees from its campuses at Bareilly along with its constituent and affiliated colleges. Post-doctoral Research Fellowships and National and International Collaborative Research Projects are also undertaken by faculty. Chaudhary Charan Singh University (formerly, Meerut University) was established in 1965, to cater to the needs of higher education in western Uttar Pradesh. The University offers Graduate, Postgraduate and Doctoral research programs in different faculties. The University has a separate engineering college, which is currently offering courses leading to B.Tech. & M.Tech degree in different branches of engineering. Now, there are five faculties with 22 aided and 35 self-financed departments being run in the campus. 252 professional colleges/institutions, 109 colleges and one constituent college are affiliated to Chaudhary Charan Singh University, Meerut.

CHAUDHARY CHARAN SINGH UNIVERSITY, Meerut and MAHATMA JYOTIBA PHULE ROHILKHAND UNIVERSITY, BAREILLY have agreed to the following protocols governing their collaboration on academic and research related activities:

1. AREAS OF COLLABORATION

The scope of collaboration on academic and research activities in this Memorandum of Understanding includes the following categories:

- Academic and Research collaboration in the areas of mutual interest.
- Exchange of academic information, scholarly information, materials and publications.
- · Exchange of students and faculty.
- Sponsorship of cooperative seminars, workshops and other academic meetings.

2. Student Exchange

Pursuant to the agreement for academic exchange, Chaudhary Charan Singh University and Mahatma Jyotiba Phule Rohilkhand University will exchange students as per mutual interest of both parties. It is desired by both parties that there will be regular flow of students in both directions.

3. Faculty Exchange / Mobility:

On invitation by the host institution, teaching staff may go for a teaching stint at the partner institution with due approvals on either side. Financial commitments will depend upon availability of support from funding agencies.

4. Research Collaboration

Faculty from both Institutions will collaborate in the supervision of exchange students and in joint research in disciplines of mutual interest.

5. Commencement, Renewal, Termination and Amendment

a) This MOU will come into force upon affixing of the signatures of the representatives of the partner institutions and will remain in effect for a period of FIVE years from the date of the last signature. This MOU may be renewed upon its expiry, with the agreement of both partner institutions. If either partner institution wishes to terminate the MOU at the end of the five years period it must notify the other institution no less than six months prior to the expiry of the MOU.

- b) This MOU or its renewal and the actions taken under it may be reviewed at any time. Modifications may be made by mutual agreement and any amendment or extension to the agreement may be formalized by the exchange of letters between the two institutions. For all issues arising out of this Memorandum of Understanding or in its implementation the concerned parties to this MoU will resolve the same amicably by mutual consent of both the
- c) Both Parties understand that all final arrangements will have to be negotiated and will depend on the availability of funds. During implementation of the present MoU both Parties shall comply with legal regulations being in force in both institutions.
- d) This MoU was made in two equivalent copies in English, with one copy for each Party. The signing parties signed the agreement themselves in person.
