# Memorandum of Understanding



This Memorandum Of Understanding (MOU) is entered into on effect on October 28, 2021, by the Education Division of the Taipei Economic and Cultural Centre in India (hereinafter referred to as TECC) having its registered office at 34 Paschimi Marg, Vasant Vihar, New Delhi 110057, and represented by Peters Chen, Director of Education Division TECC, and the Mahatma Jyotiba Phule Rohilkhand University (hereinafter referred to as MJPRU), Bareilly, an Institute incorporated in India and having its Registered Office at Pilibhit Bypass Rd, M.J.P Rohilkhand University, Bareilly, Uttar Pradesh 243006 and represented by, Vice Chancellor Prof. K. P. Singh of Mahatma Jyotiba Phule Rohilkhand University, Bareilly, cooperating in Mandarin Chinese teacher and establishment of Taiwan Education Centre for academic cooperation.

**The terms of this Agreement consist of the following:**

- A. Education Division TECC will facilitate Mahatma Jyotiba Phule Rohilkhand University, Bareilly in disseminating knowledge about Mandarin Language, promoting bilateral educational opportunities.
- B. The person will be an instructor who has expertise in designing the teaching curriculum and evaluation of the foreign language course in Mandarin to students. The Instructor shall be responsible for teaching Mandarin Language course over a period of required semesters for general purposes.
- C. Institution shall provide designated office space as the instructor's office and Taiwan Education Centre, and classroom space for the instructor to conduct classes, seminars, administration regarding bilateral relation and exchange programmes, etc.



- D. Education Division TECC will send Instructor (s) to the campus of Mahatma Jyotiba Phule Rohilkhand University, Bareilly, and help establish the pedagogical and methodological bases for the Mandarin Language Course.
- E. **The instructor shall meet the following requirements:**
1. Bachelor/Master/Doctoral Degree in humanities, language or related fields.
  2. Certification in teaching Mandarin as foreign language.
  3. Knowledge of English as medium of instruction.

F. **Services and Cost:**

Mahatma Jyotiba Phule Rohilkhand University, Bareilly will provide the following benefits to the instructor:

1. MJPRU Bareilly will pay the instructor an amount of foreign guest faculty as honorarium per month as per mutual consent.
2. Fee for applying employment visa from India Taipei Association.
3. Fee for extending visa from Foreigner Regional Registration Office (FRRO).
4. Assistance on acquiring employment visa and immigration-related issues.
5. Furnished accommodation on the campus and academic facilities as provided to guest faculty at no cost.
6. Free use of the medical facilities including doctor visit and medicine in the campus at no cost.
7. The Instructor can also purchase the same medical insurance offered to Mahatma Jyotiba Phule Rohilkhand University, Bareilly employees at the same rate. This means that along with the use of medical facilities and medicines from Mahatma Jyotiba Phule Rohilkhand University, Bareilly chartered hospitals, the Instructor will have medical insurance to have treatment outside of the institution as well, in case of an emergency.

The instructor/instructors, through Taiwan Education Centre, are expected to cater and promote the following responsibilities/activities along with other responsibilities as deemed fit in the interest of this centre with mutual consent.

1. Teach Mandarin courses in Mahatma Jyotiba Phule Rohilkhand University, Bareilly.
2. Distribute information of scholarships, internships and exchange programmes to students and faculty of Mahatma Jyotiba Phule Rohilkhand University, Bareilly.
3. Improve bilateral collaboration between Mahatma Jyotiba Phule Rohilkhand University, Bareilly and Taiwanese Universities/Institutes for internationalisation.



### G. Duration and Amendment of Agreement

This Memorandum of Understanding is effective from the date when representatives of the two institutions affix their signatures, and is valid for three years. This Memorandum of Understanding, with the written consent of both the institutions, may be amended, extended or terminated, with a three (3) months' period of prior notice, by either institution. This Memorandum of Understanding is renewed automatically as long as neither institution gives notice of termination to the other three (3) months prior to the end of the three years term.

### H. Equal Opportunity


Both parties subscribe to the policy of equal opportunity and will not discriminate on the basis of race, sex, sexual orientation, age, religion or national origin.


