MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (hereinafter called as the 'MOU') is entered into on 12th December, 2019.

WHEREAS:

A) First Party is a Higher Educational Institution named:

- B) First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.
- C) The Parties intent to cooperate and focus their efforts on cooperation in the area of Skill Based Training.

- D) Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interest;
- E) Country Inn and Suites by Radisson is engaged in the Business of Hospitality Service & Trainings.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

CLAUSE 1 CO-OPERATION

- 1.1 Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the **Hospitality Industry**, and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.
- 1.2 First Party and Second Party co-operation will facilitate effective utilization of the capabilities of the faculty of First Party in providing teaching / training systems, keeping in mind the needs of the industry, the Second Party.

CLAUSE 2 SCOPE OF THE MOU

- 2.1 The budding graduates from the institutions could play a key role in technological up-gradation, innovation and competitiveness of an industry. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.
- 2.2 **Curriculum Design:** Second Party may give valuable inputs to the First Party in teaching / training methodology and suitably customize the curriculum according to Industry needs so that the students fit into the industrial scenario meaningfully.
- 2.3 **Hospitality Training:** Industry and Institution interaction will give an insight into the latest developments / requirements of the industries to the students during the industrial training. This exposure provided to students

and faculty through this association will build confidence and prepare the students to have a smooth transition from academic to working career.

2.4 Internships and Placement of Students: Second Party will assist in training and placement of students of the First Party.

2.5 Skill Development Programs: Second Party to train the students of First Party on the emerging technologies in order to bridge the skill gap and make them industry ready.

2.6 Guest Lectures: Second Party to extend the necessary support to deliver guest lecturers to the students of the First Party on the technology trends and in house requirements.

CLAUSE 3

3.1 Both Parties to obtain all internal approvals, consents, and permissions of whatsoever nature required for offering the Programs on the terms specified herein.

3.2 There is no financial commitment on the part of the both the parties mentioned in the MOU Name of institution.

CLAUSE 4 VALIDITY

4.1 This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms, Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their previous obligations

CLAUSE 5 RELATIONSHIP BETWEEN THE PARTIES

5.1 It is expressly agreed that First Party and Second Party are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is

authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.
