
IFS and Dept. of Economics, MJPRU, are here in under collectively referred to as "Parties" and individually as "Party".

**A) Role of IFS:**

- ii. Arranging Speakers

**B) Role of Dept. of Economics, MJPRU**

- ii. Share information about registrations/participants
- iii. Arrangement for hospitality etc.
- iv. Wide circulation of the program /coverage on its website

II) IFS and Dept. of Economics, MJPRU shall work towards promotion of training research in Entrepreneurship Development and Business Management

III) There are no financial implications (unless specifically agreed for a particular program) involved between IFS and Dept. of Economics, MJPRU, as a part of this MoU.

IV) Any other activity that both Parties may mutually decide and agree upon from time to time in order to bring the awareness about the Entrepreneurship Development & Business Management among the higher education and its stakeholders.

**NOW THIS MEMORANDUM WITNESSETH AS UNDER:**

**Representation and Warranties**

The representation and warranties by both parties are as under:

- i) Each party warrants, agrees and undertakes that it is legally constituted under the applicable laws, and is free and competent to enter into this MoU.
- ii) The execution of this MoU is not contravention to the laws to which both parties are subjected to.
- iii) All the necessary approvals for execution of this MoU have been obtained and all such approvals are valid and remain in force on the date of this MoU.

**Duration:** The MoU shall expire upon completion of Three (3) years term and extended up to Five (5) years from the date of this MoU after which both Parties mutually agree upon to extend the term. However, in case of exigency, the MoU can be terminated by either Party by giving Thirty (30) day's written reason notice.

**Liability:** Both Parties agree that they are not liable to each other, or any other party not entering into the said MoU, for any damages including any special, incidental, consequential, or indirect damages arising from any claims arising out of this MoU.

**Dispute Resolution:** Any and all disagreements/differences/disputes arising on account of any reason shall be resolved amicably by the designated senior executives /officers of the good offices of both Parties.


**Entire MoU:** Both Parties of this MoU shall abide by the terms of this MoU with regard to Confidential Information and Purpose, and shall make reasonable efforts towards achieving the purpose outlined in this MoU.




