

# MEMORANDUM OF UNDERSTANDING

BETWEEN

This MoU is entered into on the 27th of August, 2019 between Bhikaji Cama Subharti College of Hotel Management (A Constituent College of Swami Vivekanand Subharti University) situated at Meerut, U.P., India

And

Department of Hotel Management, MJP Rohilkhand University, Bareilly, U.P., India

The general objective of this Memorandum of Understanding (MOU) is to stimulate and facilitate the development of collaborative and mutually beneficial programs which serve to enhance the interests in the field of education and research.

## 1. Objectives of the MoU

- (a) To promote and enhance academic interest between both Institutions.
- (b) To provide advice for implementation of quality of education.
- (c) To encourage bright students to join student exchange programme.
- (d) To promote research/continuing education activities between both institutions.

## 2. Technical Areas of Collaboration

Both the institutions must agree to:

- (a) A continuing quality improvement programme for teaching staff.
- (b) Provide academic interactions by delivering guest lectures.
- (c) Provide necessary help in organizing workshops/conferences/seminars.
- (d) Provide necessary support for conducting research work, industrial visits & training & placement.
- (e) Provide help for infrastructural development.

## 3. Terms & Conditions

- (a) For the visit related advice consultancy, travel and other expenses of faculty & staff shall be reimbursed on mutually agreed.
- (b) Both the institutions agreed to help and share information related to participation in conferences/workshops and short-term courses.
- (c) This MoU may be amended, renewed and terminated by mutual written agreement of the institutes at any time.

4. **Duration of MoU**

This MoU shall be expired in five years after the effective date specified in the opening paragraph, unless extended by mutual written consent of the institutes.


5. **Coordinators**


